

**HARTFORD COURANT SKI, SUN + TRAVEL EXPO SWEEPSTAKES**  
OFFICIAL SWEEPSTAKES RULES 2016

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

The Hartford Courant Ski, Sun + Travel Expo Sweepstakes (the "Sweepstakes") starts at 10 a.m. (ET) on Sunday, October 30, 2016 and ends at 4 p.m. (ET) on Sunday, October 30, 2016 (the "Sweepstakes Period"). The sponsor of this Sweepstakes is The Hartford Courant Company, LLC ("Sponsor"). The Sweepstakes will be subject to these Official Rules, and by entering, all entrants agree to abide and be bound by the terms and conditions herein and the decisions of the Sponsor.

The odds of winning the Grand Prize depend on the number of eligible entries received for Grand Prize drawing.
